The **Legal Fund** was discussed. Duane Ferris moved that the board be authorized to increase the Legal Defense Fund as appropriate. Thomas Frey 2^{nd} . Vote of the membership, motion carried with 1 opposed. It was stressed the board would not deficit spend, but would appeal to members for additional legal funds, should the need arise.

Helena Township Master Plan will take Public comment Wed. at 7:00. Paul called attention to several items which would affect Clam Lake including road ends and access sites, funnel

development, commercial development, and residential home size and encouraged members to attend and have their comments heard.

Member Comment:

Jim Marling reported it had been a pleasure to serve on the board and wished Fred Sittel well. He said he would continue to serve as Chairman of the By-Laws Committee and Alba Well and would attend the board meetings as a non-voting participant. (Applause for his service)

Bob Schaefer said we should continue to work with Grass River on items such as loon watch and other activities which affect Clam Lake.

Duane Ferris reported Purple Loosestrife growing on the shoreline of Clam River near the bridge. Fred Sittel will look into this.

Thomas Frey reminded everyone that Clam Lake is a public lake and that our organization is committed to the protection of the lake for all who live, play and/or work on Clam Lake.

Adjournment: Jim Marling moved the meeting be adjourned. Carol Hoadley 2nd. Vote of the membership, motion carried. Meeting adjourned at 9:02 p.m.
